Players and Parent/Guardians understand that participating in recreational and related activities at the Stop the Silence-Flint 3-on3 Basketball Tournament presents a risk of personal injury, death and damage to or loss of personal property.

Participation in recreational and related activities carries with it certain inherent risks that cannot be eliminated regardless of the care taken to avoid injuries. The specific risks vary from one activity to another, but the risks range from 1) minor injuries such as scratches, bruises, and sprains 2) major injuries such as eye injury or loss of sight, joint or back injuries, heart attacks, and concussions to 3) catastrophic injuries including paralysis and death. In addition, a risk is present for personal injury which may result from, but is not limited to the following: fishing in or around, and wading in or around rivers, ponds, irrigation ditches, or other bodies of water; natural hazards including, but not limited to lightning, storms and other adverse weather conditions; domestic and wild animals; insect bites; and travel either on foot or in a vehicle in unfamiliar terrain, over artificial and natural obstructions and unimproved roads.

I also understand that in order to be allowed to participate, I must give up my rights to hold The Regents for the University of Michigan, a Michigan constitutional corporation, of the University of Michigan-Flint ("UM-Flint") its directors, staff, agent, sponsors and affiliates liable for any damage in which I may suffer while participating in activities. Knowing this, and in consideration of being permitted to participate, I hereby voluntarily release UM-Flint, its directors, staff, agents and sponsors from any liability resulting from or arising out of my participation in the Stop the Silence-Flint 3-on-3 activities.

I understand and agree that this release will have the effect of releasing, discharging, waiving, and forever relinquishing any and all actions or causes of action that I may have or have had, whether past, present, or future, whether known or unknown, and whether anticipated or unanticipated by me, arising out of my participation. This release constitutes a complete release, discharge, and waiver of any and all actions or causes of action against UM-Flint, its directors, staff, agents, sponsors or event affiliates.

I understand and agree that this release applies to personal injury, property damage, or wrongful death, which I may suffer, even if caused by the acts or omissions of others.
